Based on the new developments announced yesterday we feel it imperative for this follow up communication. On the evening of March 19, 2020, Governor Newsom of the State of California issued an executive order "Safer at Home". This order requires all individuals living in the State of California to stay at their place of residence, **EXCEPT** as needed to maintain continuity of operation of the federal critical infrastructure sectors. Conesys, its subsidiaries and its employees are **EXEMPT** from this order as we qualify as 1 of the 16 identified federal critical infrastructure sectors, more specifically under the "Defense Industrial Base Sector".

- We are proactively working on contingency plans to ensure continuity of business operations during these unprecedented times.
- We are adding additional supplies from vendors above normal usage as a safety measure.

Lastly, Conesys is implementing defensive measures listed below, in the interim, to protect our employees and business operations:

- Limiting non-essential travel and face-to-face meetings/visits.
- Encouraging conference calls and web meetings.
- Expanding remote work options.
- Reinforcement of sanitization and hygiene procedures throughout the facility.
- Frequent cleaning and disinfecting all facility work, lunch and high traffic areas.
